# SJECCD LEGISLATIVE PRIORITIES

San José - Evergreen Community College District (SJECCD) proudly presents its 2025 Legislative Priorities, supporting our work to advance student success, equity, and strong institutional operations.

Our state priorities focus on student needs—including college access and affordability, student success, housing and basic needs, and support for vulnerable populations—as well as community college baccalaureate degrees and legislation related to general college operations such as state funding, human resources, and governance.

Our federal priorities focus on Pell Grant reform, including efforts to increase award amounts, expand eligibility to short-term programs, and eliminate taxation of Pell Grants.

We've organized the proposed legislation by policy area in the tables below and to the right, with page numbers that point to information on the District's position—Support, TBD, or Monitor—and additional details for each supported bill.

# **2025 SJECCD STATE LEGISLATIVE PRIORITIES**

# **STUDENT NEEDS**

Ensuring student success requires policies that remove financial and structural barriers while providing essential support. SJECCD advocates for legislation that expands educational opportunities, strengthens pathways to degree completion, and ensures students have access to the resources they need to succeed academically and beyond.

The following student needs priorities guide these legislative efforts:

# **#1** College Access and Affordability

Expanding financial aid, simplifying applications, and ensuring higher education remains accessible for all students.

#### **#2** Student Success

Strengthening academic pathways, career development, and transfer opportunities to improve retention and degree completion.

# **#3** Housing and Basic Needs

Supporting access to housing, childcare, and essential resources so students can stay enrolled and focused on their education.

# **#4** Support for Vulnerable Student Populations

Protecting the rights and educational access of students impacted by immigration enforcement or status.



# 1 COLLEGE ACCESS AND AFFORDABILITY

# SB33 – Homeless Pupils

California Success, Opportunity, and Academic Resilience (SOAR) Guaranteed Income Program

(Author: Cortese)

Bill would require the State Department of Social Services to establish the SOAR Guaranteed Income Program, subject to an appropriation.

The program would award public school pupils who are in grade 12 and are homeless children or youths a guaranteed income of \$1,000 each month for four months, from May 1, 2026, to August 1, 2026.

# SB67 & AB88\* - Student Financial Aid

Cal Grants: Middle Class Scholarship Program: Eligibility: Dependents of Members of the Armed Services Stationed Outside of California

(Authors: SB67 - Seyarto, AB88 - TA)

Bill would extend Cal Grant and Middle Class Scholarship Program (MCSP) eligibility to a student who was not a California resident at the time of their high school graduation or its equivalent but meets all other eligibility requirements.

The student must also be a dependent natural or adopted child, stepchild, or spouse of a member of the U.S. Armed Forces who otherwise maintains California as their state of legal residence.

# **SB363** – Community Colleges

CalWORKS Recipients Education Program: Eligibility and Services

(Author: Bryan)

Expands access to the California Community College's CalWORKS Recipients Education Program to include those whose dependents receive CalWORKS benefits and expands the permitted use of funds provided for the CalWORKS education program.

# **AB537** – Community Colleges

California College Promise

(Author: Ahrens)

Bill would remove, for purposes of eligibility for the California College Promise, the qualification that students be full-time. The bill would additionally require, as a condition of participating in and receiving funding for the California College Promise, that community colleges and community college districts refrain from referring to any other student financial aid funding or program as the California College Promise.

#### **AB731**– School Attendance

College and Career Access Pathways Partnerships (Author: Fong)

Bill would require a CCAP partnership agreement to establish protocols that authorize a pupil to complete one application for the duration of the pupil's attendance at a community college as a special part-time student participating in a CCAP partnership agreement.

# **AB1035** – Community Colleges

California College Promise: Fee Waiver Eligibility (Author: González)

Bill would authorize extending the term of eligibility of the California College Promise for an additional two academic years for first-time community college students and returning community college students who matriculate into upper-division coursework of a community college baccalaureate degree program, as specified.

# STUDENT SUCCESS

# **AB323** – Strong Workforce Program

**Work-Based Learning Opportunities** (Author: Fong)

Bill would require the Chancellor's Office to revise, no later than June 30, 2026, the policies of the Strong Workforce Program, including its regulations, and guidance necessary to provide students, employers, or both, with paid work-based learning opportunities, as provided. The bill would authorize a community college district to also use funds apportioned directly to CCDs to provide direct support to students, employers, or both, for paid work-based learning to increase employability and employment, as provided.

# **SB271** – Public Postsecondary Education

Students with Dependent Children: Childcare Services, Resources, and Programs (Author: Reyes)

Bill would expand the definition of basic needs services and resources to include childcare services and resources, as defined.

# **AB79** – Public Social Services

**Higher Education** (Author: Arumbula)

Bill would require a county human services agency to additionally receive input from basic needs directors, basic needs coordinators, or designated staff, as specified, when developing protocols for engagement between the county human services agency and institutions of public higher education.

# SUPPORT FOR VULNERABLE **STUDENT POPULATIONS**

# **SB307** – Public Postsecondary Education

**Access: Immigration Status** 

(Author: Cervantes)

Bill would state the intent of the Legislature to enact future legislation to address challenges and barriers in accessing a higher education degree in the event of the arrest, imprisonment, detainment, or deportation of a student, including arrangements for the online continuation of their courses to enable the completion of their degree programs.

# **AB695** – California Community Colleges

**Access and Continuity for Deported Students Act** (Author: Fong)

Bill would exempt a community college student from paying nonresident tuition if the student has been involuntarily removed from the United States due to immigration enforcement actions, was not paying nonresident tuition at the time of deportation, provides proof of deportation status, and reenrolls in a community college online education program.

The bill would require a deported student who legally reenters the United States and resumes in-person education at a community college to be eligible for nonresident tuition, provided the student was previously classified as a resident and eligible for the nonresident tuition exemption at the time of deportation, and would require the student to be eligible for financial aid upon reenrollment.

The bill would require the Board of Governors to adopt specified regulations related to the bill, including regulations that establish procedures for verifying deportation status and eligibility.

# **COMMUNITY COLLEGE BACCALAUREATE DEGREES**

Advancing community college baccalaureate programs provides affordable, workforce-aligned pathways that meet regional labor needs.

These programs address workforce shortages and create high-demand degree opportunities without the cost of transferring to a four-year institution.

AB 1400 advances this effort by establishing a pilot program to offer Bachelor of Science in Nursing degrees at select community colleges, helping meet the growing demand for qualified healthcare professionals across the state.

# **AB1400** – Community Colleges

Baccalaureate Degree in Nursing Pilot Program (Author: Soria)

Bill would require the office of the Chancellor of the California Community Colleges to develop a Baccalaureate Degree in Nursing Pilot Program that authorizes select community college districts to offer a Bachelor of Science in Nursing degree. The bill would limit the pilot program to 15 community college districts statewide and would require the chancellor's office to develop a process to identify and select eligible community college districts based on specified criteria.

# GENERAL COLLEGE OPERATIONS AND ADMINISTRATION

Ensuring the long-term success of community colleges requires promoting equitable funding, strengthening faculty and staff support, and enhancing governance structures that improve institutional effectiveness.

SJECCD advocates for legislation that focuses on:

# **#1** State Funding

Securing sustainable and equitable funding models to support student success, workforce programs, institutional growth, and infrastructure improvements.

### **#2** Human Resources

Supporting student success through development of a strong, dedicated, well-trained, and institutionally supported California Community Colleges workforce.

# **#3** Governance and Administration

Improving governance structures, institutional coordination, and strategic planning to strengthen college operations, student services, and facilities development.

# **AB537**\* – Community Colleges

California College Promise

(Author: Ahrens)

Bill would remove, for purposes of eligibility for the California College Promise, the requirement that students be full-time. The bill would additionally require, as a condition of participating in and receiving funding for the California College Promise, that community colleges and community college districts refrain from referring to any other student financial aid funding or program as the California College Promise.

# **GOVERNANCE AND ADMINISTRATION**

# **AB48** – Education Finance

Postsecondary Education Facilities: College Health and Safety Bond Act of 2026 (Author: Alvarez)

Bill would authorize state general obligation bonds to fund the construction and modernization of postsecondary education facilities. It aims to improve college and university infrastructure by addressing seismic safety, hazardous materials removal, and emergency response while enhancing student access to healthcare and mental health services. The bill requires voter approval and includes accountability measures such as independent audits and a cap on administrative costs.

# AB409 - Open Meetings

Teleconferences: Community College Student Body Associations and Student-Run Organizations (Author: Arumbula)

Bill would delete the January 1, 2026, sunset date for authorizing alternate teleconferencing provisions related to notice, agenda, and public participation.

# 2025 SJECCD FEDERAL LEGISLATIVE PRIORITIES

# **PELL GRANT REFORM**

At the federal level, SJECCD supports Pell Grant Reform to promote access, affordability, and student success in higher education.

Priorities include:

# **#1** Increasing Pell Grant Award

Raising the maximum Pell Grant to help low-income students cover tuition and essential college expenses, reducing the need for student loans.

# **#2** Expanding Short-Term Pell Eligibility

Expanding access to Pell Grants for workforce training programs under 16 weeks, ensuring students can gain critical job skills in high-demand fields.

# **#3** Ending Taxation of Pell Grants

Making Pell Grants tax-free so low-income students receive the full benefit of their financial aid without additional financial burdens.

By working alongside policymakers, education leaders, and community stakeholders, SJECCD remains committed to removing financial barriers and promoting equitable access to higher education.



# Increasing Amount of Pell Awards

**Support Student Access and Success** 

Boost the Pell Grant maximum award. Pell Grants enable millions of low-income community college students to pay tuition and fees and meet other college expenses and are the foundation of all other student aid. Increasing the maximum award promotes affordability and student success for low-income students, while reducing their need to borrow.

# **Short-Term Pell Eligibility**

Bolster the Role of Community Colleges in Workforce Development

Establish Pell Grant eligibility for shorter-term programs, accompanied by rigorous quality standards. Currently, programs must be at least 16 weeks long to be eligible for Pell Grants. This excludes many community college workforce-oriented programs that benefit both students and local businesses. Without Pell grant support, many students cannot afford to participate in these programs. The threshold for Pell Grant eligibility should be shortened to 150 clock hours, as was proposed in the bipartisan Senate legislation the JOBS Act and the House Bipartisan Workforce Pell Act.

# **End Taxation of Pell Grants**

Focus Student Tax Policy on Those Who Can Benefit Most


Make Pell Grants tax-free. Congress should use planned action on the Tax Cuts and Jobs Act through reconciliation to eliminate this penalty on low-income students. Currently, community college students must pay taxes on their Pell Grant dollars that are used toward living expenses. By law, these funds must be used for qualified educational expenses and taxing Pell Grant funds makes it even harder for the lowest-income community college students to succeed.


# SJECCD STUDENT DEMOGRAPHICS (2023-24)


# STUDENT ETHNICITY PROFILE




# **STUDENT GENDER**
