### **Facilities Master Plan Update**

A Facilities Master Plan is a strategic document that outlines SJECCD's vision for its facilities over the next 10-15 years. This project is an update to the Facilities Master Plan (FMP).

#### The FMP DOES:

- Provide a long-term vision
- Guides capital improvements
- Supports organizational goals
- Facilitates informed decision-making
- Establishes a framework for future facility development
- Address all District properties, including both colleges

The FMP DOES NOT:

- Provide day-to-day operations guidance for facilities maintenance, cleaning or other routine tasks
- Replace detailed project plans
- Provide a complete blueprint for every aspect of facilities management
- Address all aspects of every organizations needs
- Eliminate the need for regular updates





But, infrastructure improvements, accessibility, and maintenance still need to be addressed to allow campuses to function properly



## There is a lot of capacity at both campuses

We used existing programming to determine how much we need on campus and found there is an **abundance of classroom space** at both campuses.

- There is an opportunity for consolidation
- There is still more room than we currently need for programs to move around.
- There are plenty of opportunities to utilize classrooms more for the programs that are growing


### Empty and underutilized buildings create a feeling of decline

- Energy across campuses is spread thin.
- Campuses need to strategically focus activity, especially student life.
- Outdoor spaces could be improved to make people feel more protected, comfortable, and delighted.

There is an opportunity to move away from the edges, to **consolidate and reinvigorate the heart** of each campus.




# Lots of academic space, not enough student life/ club spaces.







#### EVC Existing Site Plan








#### EVC Proposed FMP Update








## SJCC Existing Site Plan





#### SJCC Proposed Renovation Project



Renovate the former bookstore space in the Student Center to be a multipurpose room



Renovate the old Main Gym (Jaguar Gym) to add restrooms and storage



Renovate GE to consolidate offices (now scattered across campus)



Convert more classrooms to labs in Science



Gradually move out of Tech Center and rent it out



Move Dentistry from Tech Center to ground floor of Business



Expand Cosmetology into Reprographics

## **Approach** Thinking about the entire site, not just building by building





## Focus on attracting students to the core

Activate existing central spaces.

Locate active uses in adjacent indoor spaces.

Create more reasons for people to walk across central spaces.

Redesign spaces to be more attractive, usable, and comfortable to be in.





## Relocate activities from the edges to the center

There is plenty of space to relocate programming at the edges of campuses to the center.

There is capacity to share rooms more often.





## Breathe new life into old spaces

There are many opportunities on both campuses for repurposing or reprogramming spaces that are underutilized.





### Improve circulation and wayfinding

Whether to or through campuses, more logical pathways are need to improve navigation and the sense of place.





## Make existing spaces more functional

Renovations will help existing buildings become more usable.








